Important Changes to Massage and Physiotherapy Coverage

The Trustees regularly review the coverage provided under the Plan and as part of a recent review, they have made some updates to the coverage for Registered Massage Therapy and Physiotherapy services. These changes are designed to enhance the responsible use of these services while ensuring they remain available to all Plan Members.

Effective October 1, 2024, the NEW calendar year maximum for Physiotherapy claims will be adjusted to \$3,250 per person and the calendar year maximum for Registered Massage Therapy claims will be adjusted to \$3,250 per person. This change applies to all Plan Members including Retirees.

The Trustees understand that changes to benefits can be challenging, but these measures are intended to maintain the quality and protect the accessibility of the services provided. The Trustees remain committed to supporting the health and well-being of our Plan Members and will continue to monitor and adjust the Plan as needed.

If your claims for Physiotherapy or Registered Massage Therapy have reached this maximum as of October 1st, no further claims will be payable for those services for the balance of this calendar year.
